

Terms and Conditions for 'Park Inside 50' Promotion for Brisbane Lions AFLW Home Games at Hickey Park.

- Information on how to enter and prizes form a part of these Terms and Conditions. If there is any
 conflict between these Terms and Conditions and any other published material, these Terms and
 Conditions prevail.
- 2. The Promoter is the Brisbane Lions Australian Football Club, Hyundai Centre, Level 5, Gate 2, 812 Stanley Street Woolloongabba, Queensland 4102, ABN 43 054 263 473.
- 3. The Promotion will open at 9.00am AEST on Wednesday 22nd January 2020 and closes at 11.00am AEST, Monday, 9th March 2020.
- 4. Entries are open to all Australian residents that meet the eligibility requirements in Clause 5 and must be lodged by the Close Time of the draw via the entry form located at www.lions.com.au/footymadebetter. Each entry relates to the selected AFLW game only and will not be eligible for future games. Therefore a new entry is required for each game.
- 5. To be eligible to enter, entrants must be over the age of 18, and do the following:
 - 5.1. complete all the necessary information fields in the online entry form at www.lions.com.au/footymadebetter, including telling us 'what would make your experience at the footy even better?'; and
