How many winners will there be and how will they be chosen?	There will be a total of 5 winners in this competition – 4 minor prize winners and 1 major prize winner. There will be two stages to the winner selection process: • a preliminary draw to determine the five finalists eligible to participate in the Major Prize Draw; and • the Major Prize Draw, which will determine the winner of the Major Prize from those five finalists. Major prize The major prize is a 2026 Hyundai Elexio Elite 2WD 88KWH in Crystal White including all statutory and on-road costs for the State of Queensland valued at up to \$59,990.
